# ARTICLES OF INCORPORATION OF VALLEY ESTATES MAINTENANCE ASSOCIATION, a non-profit corporation

The undersigned, acting as incorporators under the Washington NonProfit Corporation Act (Revised Code of Washington 24.03), hereby adopt and execute the following Articles of Incorporation

#### **ARTICLE I**

#### Name

The name of this corporation is Valley Estates Maintenance Association.

#### ARTICLE I I

#### Duration

The period of duration of this corporation shall be perpetual.

# **ARTICLE III Purposes**

The purposes for which this corporation, a non-profit organization, are formed are:

- 1.To acquire, construct, maintain, and operate a cooperative building or buildings, recreational facilities, and other structures for the housing and accommodation of owners, occupants, and residences of homes within Valley Estates Plat, recorded in Volume DD-58 1419 of Plats, page 380, Auditor's File No. 302865, records of Yakima County.
- 2. To engage in and carry on any activity which may be lawfully carried on or engaged in by a non-profit corporation organized under the provisions of RCW 24.03.

#### **ARTICLE IV**

### Classes of Membership

The corporation shall have one class of members. Each owner of a fee simple title to any lot within the Valley Estates plat shall be entitled to one membership.

#### **ARTICLE V**

# **Registered Office**

The address of the initial registered office of the corporation shall be 1830 South First Street, Yakima, Washington 98903. The name of the initial registered agent of the corporation at such address shall be Arthur J. Berger.

#### **ARTICLE VI Directors**
